## PRODUCT DESCRIPTION

## HOW TO USE / ADVICE

Carefully break the vial with the appropriate breaker, mount the dispenser and apply the contents on the areas to be treated and massage until completely absorbed.

For better penetration of the concentrate it is recommended to apply a compress with a mud or a bandage afterwards. Alternatively you can use the product with equipment for electroporation and oxygen therapy.

## ACTIVE INGREDIENTS / EFFECTS

**Caffeine:** promotes lymphatic drainage and stimulates lipic metabolism.

**Milk thistle:** thanks to the high content of silymarin, it is able to promote the synthesis of collagen 1 and elastin in fibroblasts and thus prevent damage due to loss of tone and elasticity of the skin.

**Birch extract:** toning, astringent, elasticizing, soothing and purifying properties.

**Horse chestnut extract:** its astringent and anti-inflammatory properties help to keep the walls of the blood vessels toned allowing the absorption of excess fluids by the circulatory system.

**Thermal salts:** improve cellular homeostasis and promote the drainage of excess fluid.
