HOW TO USE / ADVICE

Apply a fair amount of product on the legs and massage with movements lenses and delicate until the complete absorption of the product. If necessary, reapply the product several times a day.

ACTIVE INGREDIENTS / EFFECTS

Natural menthol: immediate refreshing effect, due to the activation of receptors that react to skin temperature. In addition to the refreshing action menthol has decongestant, antipruritic, antiseptic and rubefacient; is a vasodilator and a mild anesthetic.

Centella asiatica extract: its draining and regenerative properties favor the disposal of excess liquids and the improvement of skin trophism.

Horse chestnut extract: its astringent and anti-inflammatory properties help to keep the walls of the blood vessels toned allowing the absorption of excess fluids by the circulatory system.

Ginkgo biloba extract: soothing and nourishing for dry, dehydrated and reddened skin.

Thermal salts: improve cellular homeostasis and promote the drainage of excess fluid.
