ACTIVE INGREDIENTS / EFFECTS

Mandelic acid: alpha hydroxy acid with exfoliating, regenerating and levelling properties. Compared to other alpha hydroxy acids it is more tolerated and is not photosensitizing.

Pure vitamin C: reference antioxidant, is essential for the good functioning of the body, vitamin C "traps" free radicals to combat the damage caused by oxidative stress. Anti-aging, anti-spots, stimulating skin tone, vitamin C also prevents collagen degradation and has a peeling effect.

Marine collagen: fibrous protein extracted from the skin and scales of sea fish, including salmon and cod, with the aim of creating products for human use to combat cellular aging. It is also useful to counteract the slow but gradual deterioration of tissues, to prevent tears and injuries of muscles and tendons and to facilitate the healing processes of wounds. Very often this protein is applied directly to the skin as a serum or cream, together with other specific ingredients, to accelerate the healing of cuts (even the deepest ones) and for the regeneration of the skin following rashes and burns.

Chemical sunscreens: also called "organic filters", are substances capable of absorbing UV radiation through a mechanism of action similar to that exercised by natural melanin.

Thermal salts: soothing and antioxidant properties.
